

CHESS

1. GENERAL TERMS

The Chess tournaments shall be organised in accordance with the most recent technical regulations of the "Fédération internationale des échecs" (FIDE). In any dispute, the English text shall be regarded as authoritative.

The programme and duration of competitions are fixed by the FISU Executive Committee in agreement with the Organising Committee. The programme of competitions shall last a maximum of seven (7) days and includes the following events:

- one (1) men's tournament (9 rounds);
- one (1) women's tournament (9 rounds);
- Team classification shall be carried out jointly for men and women.

Each country is authorised to enter a maximum of thirteen (13) persons: eight (8) competitors and five (5) officials. Each country may enter a maximum of eight (8) competitors:

- a maximum of five (5) men and three (3) women, or five (5) women and three (3) men, or four (4) women and four (4) men

Only countries with three (3) competitors or more, of whom at least one (1) man and one (1) woman, shall be taken into account for team classification.

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

Individual classification shall be based on the total of points scored during the game. In case of a tie, the winner shall be determined according to the FIDE rules and the tournament rules applicable to the concerned Chess Championship.

Team classification shall be based on the total of points scored in the individual tournament and on the three (3) best scores of at least one (1) man and one (1) woman from the same country. If the number of men is equal or more than 1.5 times the number of women, team classification shall be based on the best results of two (2) men and one (1) woman. Similarly, if the number of women is equal or more than 1.5 times the number of men, team classification shall be based on the best results of two (2) women and one (1) man.

In the event of a tie, the winning team shall be determined according to the FIDE rules.

2. PRE-COMPETITION PROCEDURE

Three months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

Seeding method

The seeding is made according to the international ELO-rating.

Players who do not have ELO-rating shall be placed at the bottom of the starting list in alphabetical order.

The pairing of all rounds shall be made with the latest version of Swiss Chess Software “Swiss Manager”. This allows an easy publishing of the results and pairings on the website “chess-results”.

3. TECHNICAL OFFICIALS

3.1 Nomination and costs

International referees shall be appointed jointly by FIDE and FISU. The Organising Committee shall bear their costs of travel, board and lodging (from two (2) days before the opening ceremony to one (1) day after the closing ceremony).

Other costs are referenced in the FISU – FIDE partnership agreement.

3.2 Number of technical officials needed and qualification

1 chief arbiter and 2 deputy arbiters shall be appointed.
